

SCREAM ENTERTAINMENT, INC. VOLUNTEER AGREEMENT

Conditions of Acceptance - Waiver and Release Agreement

I hereby acknowledge and agree that any activities I provide for Scream at the Beach, unless a separate written agreement is mutually executed, will be exclusively as a volunteer on behalf of Scream Entertainment, Inc., a nonprofit charitable organization, not as an employee, and therefore I have no expectation of and hereby waive and release any claim for personal compensation, remuneration or benefits in any form at any time. I hereby attest that my attendance and involvement are voluntary, that I am participating at my own risk, and that I have read, understood and accept the conditions of this release.

I also release, indemnify and hold harmless the Releasees identified hereafter from any and all claims, actions, costs, expenses, judgments or damages of any and every kind and character, whether statutory or arising in contract or in tort, for any injury to my person or loss of my property, directly or indirectly arising out of or in conjunction with or attributable to my participation in such activities, including but not limited to claims or damages for death, bodily injury, psychological trauma or property damage arising in whole or in part from the negligence of any of the Releasees and/or from negligence on my part.

As used herein, the term "Releasees" shall mean (a) Scream Entertainment, Inc.; (b) TW Productions LLC; (c) any and all corporations, individuals or entities sponsoring or supporting the aforementioned activities; (d) any and all corporations, individuals or entities participating in the construction of and/or the operation of and/or any activities relating to the said activities; and (e) any and all corporations, individuals or entities who are in any way associated with any of these activities.

I hereby confirm, represent and warrant that I have never been convicted of or charged with a violent crime, child abuse or neglect, child pornography, child abduction, kidnapping, rape, stalking or any sexual offense, of whatever degree, nor have I ever been ordered by a court to receive psychiatric or psychological treatment in connection with any such acts.

I hereby grant to Releasees the irrevocable right and license to use my likeness and/or voice in any manner or media at any time, including any portion thereof, without limitation, in perpetuity at their sole discretion and to use my name, likeness, voice and biographical or other information concerning me in connection with Scream at the Beach, including promotion in all media, and I agree to appear without pay.

I further agree to hold Releasees harmless against any liability, loss or damage resulting from use of my image and/or voice, and I hereby release and discharge Releasees from any and all claims whatsoever in connection with such use.

Scream Entertainment, Inc. and/or its representatives may authorize any and all medical treatment and/or transport in the event I become ill or injured while participating in any of the activities on site or related to Scream at the Beach.
